# <u>Elevate-Unnati (Idea2PoC Grant-in-aid for Startups by SC/ST</u> <u>Entrepreneurs)</u>

#### Introduction:

Elevate-Unnati is a first of its kind joint initiative from Department of Social Welfare, and Department of Electronics, IT, Bt and S & T, Government of Karnataka which aims to provide a comprehensive Entrepreneurship platform for Startups.

#### **Objective:**

The objective is to identify innovative technology solutions by Startups promoted by SC/ST Entrepreneurs, release grant-in-aid, mentorship, subsidized incubation, incentives and reimbursements and eventually provide market access.

#### **Background:**

The program consists of calling for online applications from Startups with innovative ideas/ solutions, checking for data sufficiency and eligibility of applications received, multi-city pitching across Tier-II & Tier-III cities by Startups in presence of association nominated jury members and officials from the Social Welfare Department (SWD) from the respective regions, final pitching by Startups in presence of panel consisting of sector experts (nominated by industry associations), validation and evaluation of scores, announcement of results, documentation and release of grants to Startups in 2 Tranches (50% of the total grant amount after signing MoA and balance 50% on successful completion of milestones). The winners are eligible to avail benefits such as subsidized incubation space in Govt. owned incubation hubs, incentives and reimbursement of patent filing cost, marketing and GST, invitation to events, knowledge sessions etc. under the Karnataka Startup Policy 2015-2020.

### Eligibility criteria for Elevate-Unnati:

• Should be an entity (Private Limited/ One Person Company (OPC) Private Limited/ Limited Liability Partnership (LLP)/ Partnership Firm) registered or incorporated in Karnataka. Private Limited Company (as defined in the Companies Act, 2013) or







registered as a Partnership Firm (registered under section 59 of the Partnership Act, 1932) or a limited liability partnership (under the Limited Liability Partnership Act, 2008).

- Total revenue generated in terms of turnover from the date of incorporation should be less than INR 100 Crore.
- Startups should not have crossed 10 years from the DATE of INCORPORATION/ REGISTRATION Certificate as on 22 January, 2020.
- Startups/Entity working towards innovation, development or improvement of products or processes or services, or if it is a scalable business model with a high potential of employment generation or wealth creation.
- At least one of the founders/co-founders should belong to SC/ST community and should hold a substantial STAKE/SHARE in the entity.
- Such SC/ST founder/co-founder should continue to be a part of the project for at least one year from the date of receiving benefits under this grant from the Department.
- Terms and conditions of ownership should not be altered to his/her disadvantage during the course of project.
- Applications not meeting the above-mentioned ELIGIBILITY CRITERIA shall be disqualified at any stage of the selection/ funding process resulting in the cancellation of their application/grant.

### **Important Instructions:**

- Registration with shops and establishment cannot be accepted as a certificate of incorporation/ registration to apply for the call.
- MSME, Udyog Aadhaar, GST, Trade Union, KMF, VAT certificates etc. shall not be considered as certificate of incorporation as per the Karnataka Startup Policy Government Order.
- The startup cannot be a subsidiary/ franchise/ white labelled reseller/ part of a group company.
- The startup cannot have a partnership value with another company/ entity.

- It cannot be a Section 8 company or Trust/ Association/Society or a non-profit company.
- It cannot be a Merger/ Demerger of a bigger organization.
- It cannot be a part of any Govt. initiative/ aided partner or public-private partnership company/firm.






