#### Preamble

Deendayal Antyodaya Yojana - National Rural Livelihood Mission (DAY-NRLM) is a national initiative of the Ministry of Rural Development (MoRD) instituted to foster economic growth and empowerment of women. In 2022-23, NRLM has planned to collaborate with different stakeholders who are working to solve the challenges of rural women and to bring all stakeholders together on one platform to resolve shared challenges together, and make it work for rural India. Accordingly, as per Ref.1, MoRD in association with 'Sanjeevini - KSRLPS' aimed to engage with the start-up ecosystem in Karnataka State towards building a synergy between start-ups/incubator agencies and SHG-based rural enterprises. Accordingly, Sanjeevini – KSRLPS has scheduled a Start-up Conclave on 18th February, 2022 at Hotel Lalith Ashok, Bangalore, which was inaugurated by Honourable Minister for Skill Development, Science & Technology, Higher Education and IT&BT. As per the interactions with selected Start-ups by Joint Secretary of MoRD, Principal Secretary, SDEL of Government of Karnataka and State Mission Directors of State Rural Livelihood Missions of Karnataka, Kerala, Tamil Nadu, Pondicherry, Telengana and Andra Pradesh, it was decided that a Start-up Challenge 2022-23 may be be organised by Sanjeevini-KSRLPS as a competition for Start-ups aimed at encouraging Start-ups to formulate innovative and relevant products and services that could be developed into viable business ventures for SHG women.

As per Ref.2, Hon. Chief Minister has launched the "Accelerating Women Enterprises" – Start-up Challenge 2022-23 on 8<sup>th</sup> April, 2022 in the presence of Hon. Minister for Higher Education, Electronics, Information & Bio Technology, Science & Technology, and Skill Development, Entrepreneurship and Livelihood. The competition was open to all Start-ups

and the themes of challenge included e-commerce, logistics, rural development, agriculture, animal husbandry, branding & merchandising, social impact, enterprise software, product design interventions, toys/art/crafts, green technology and waste management. A Challenge Fund of Rs. 15 Lakhs for selected start-ups was earmarked under NRLM and TiE, Bangalore Chapter and GAME (Global Alliance for Mass Entrepreneurship) acted as the Knowledge Partners for this initiative. As per Ref.2, it was announced that Winner Certificates, Prize Money of INR 5 Lakhs as Challenge Fund for presenting potential projects that facilitate growth of Sanjeevini-KSRLPS will be awarded to three toppers. It was also announced that the winners will be provided with an opportunity to implement the project, subject to approval under NRLM and all the finalists will be provided with the Mentorship opportunity from Technical & Leadership Experts of TiE, Bangalore and GAME (Global Alliance for Mass Entrepreneurship).

As per Ref.3, a Judging Panel was constituted by Sanjeevini – KSRLPS and the Judging Panel evaluated the proposals of Start-ups. 300 Start-ups applied for the Start-up Challenge and out of which, 153 Start-ups became eligible for the challenge rounds. Later, 31 Start-ups qualified for the second challenge round, and finally 12 Start-ups became eligible for the final round. A pitching session for the finalists was conducted on 3<sup>rd</sup> August, 2022 and the panel has evaluated the finalists based on criteria such as innovativeness & solution (competitive advantage, business model, scalability), readiness of product/prototype, team (expertise) and ability to execute and realize their business plan and sustainable development and tech-forgood impact. As per Ref.3, the panel has selected three winners as given below to collaborate with Sanjeevini – KSRLPS.
